- If institution has any mean of proof such as video, of doing so then only, institution should summon me in office.
- Any mean's of false allegation regarding the incident on 18/may/2024 will taken harassment from my side and prosecuted legally in court.
- The student from camera are recovered they are falsely including me in this matter, the institute still should take proper action on this student.
- on 18/may/2024, student from camera are recovered, falsely accuse two student.

Instructions for Security:

Guards were instructed to tighten security and ensure no one left the premises without a thorough check.

Student Inquiry:

Students from various floors were questioned, but no one admitted to any involvement or provided information.

CCTV Footage Analysis:

The footage revealed that one cable was cut at 10:13 PM and three more at 10:37 PM, leading to the cameras going offline. Following this, one camera from the ground floor and one from the first floor were damaged and stolen.

Discovery of Stolen Cameras

At 12:30 AM, during a routine check at the hostel gate, security guards found two stolen cameras in the bag of Mr. Naman (22EBKAI031, 2nd Year, AI, Block A, Room 57), who was leaving with an out pass for an examination in Jaipur.

Statements Collected:

1. Mr. Naman's Statement: Claimed the cameras were given to him by his brother, Mr. Aman Singh (22EBKEC003, 2nd Year, EC, Block A-57).
2. Mr. Aman Singh's Statement: Stated that he received the cameras from Mr. Himanshu Kumar (22EBKDS021, 2nd Year, DS, Block C, Room 65).
3. Mr. Himanshu Kumar's Statement: Denied giving the cameras to Mr. Aman Singh and claimed no involvement in the incident.

Date of Incident: 18th May 2024

Location: Hostel A Block

Details of Incident: Damage and Theft of CCTV Cameras

On the night of 18th May 2024, four newly installed CCTV cameras in A Block were damaged and two cameras stolen and recovered at hostel gate by security.

Timeline of Events

10:13 PM: One cable was cut on the roof of the building.

10:37 PM: Three cables were cut on the roof of the building.

Following the cable cuts, two cameras were broken and stolen: one from the ground floor and one from the first floor.

Notification to Authorities

At 11:04 PM, the night duty security guards informed the hostel superintendent that two cameras had been stolen. The identity of the perpetrators was unknown.

Response and Investigation

11:10 PM: The hostel superintendent arrived at the hostel.

The superintendent called Mr. R.S. Shekhawat (Floor Warden, Ground Floor) and Mr. D.C.Sharma (Floor Warden, First Floor) to begin the investigation.

As per the notice (BKBIET/PO/2023-24/076) from Principal Sir dated 23 May 2024 the discipline committee is asked to investigate the incident. The report from the discipline committee is as follows:

Discipline Committee Report

Incident

Two cameras were found missing from the hostel Block-A, one from I floor and another one from II floor. Following the incident, the discipline committee investigated to determine the responsible persons.

Investigation

The committee carried out a thorough investigation which included:

- Interaction with parties (Students).
- Reviewing surveillance footage.
- Inspecting the damaged property.
- Gathering written statements from involved parties (Students).

Findings

1. **Student Naman (22EBKAI031):**
 - Plucked cameras found in his bag at security gate when he was going out of hostel at 12:30AM from hostel.
 - As per Mr. Aman, he was not knowing that cameras were in his bag. (That is unbelievable.)
2. **Student Aman (22EBKEC003):**
 - Mr. Himanshu gave him cameras to hide.
 - Due to fear of being caught, he put the cameras in the bag of Mr. Aman without telling him.
3. **Student Himanshu (22EBKDS021):**
 - Not admitted for plucking and giving the cameras to Mr. Aman.
 - As per footage, Mr. Himanshu was in A-Block from 10:00 PM to 11:00 PM (during the time of plucking cameras).
 - Two students, Mr. Ayush Sinha(22EBKIT006) and Navneet Pandey (22EBKAI033) witnessed the for the talks/planning between Mr. Himanshu and his friend for plucking the cameras.

Conclusion

The committee finds the following:

- Mr. Himanshu is directly involved in plucking the cameras as per witness.
- Mr. Naman's role was encouraging the act and disbursement of cameras from hostel to outside.
- Mr. Aman was involved in disbursement of cameras.
















Recommendations by the Committee
